A Small But Mighty Parcel of New Conservation



In 1949, Lester and Mary Hurd purchased this parcel, part of a 6-acre property on the banks of the Cousins River in Freeport. In 1958, the Maine DOT constructed Route 295 south by taking

part of the property using eminent domain laws. They altered the course of the Cousins River so they could build a bridge for the road. They divided the property in half leaving the east portion accessible only though gates in the state boarder fences. Then in 1982, the state DOT once again came and took more of the property using eminent domain laws to divide what was left in order to change the south bound lanes to travel north bound and build a new road to travel south bound. This action took all the property that the family home was on but left approximately 2+ acres of inaccessible, undeveloped property on the shore of the Cousins River's west branch. This property was deeded over to Lester and Mary's youngest son David in February of 2006. With limited access the real value is as conserved land because it abuts 193 acres of FCT conserved land along the Cousins River Marsh. Thank you to David and his wife Mary, whom recently decided to donate it to FCT hoping to keep it natural as it is today with the dream of a recreational trail.
